Behind the Data

Bloomberg Government looked at the 2,139 registered lobbying firms that filed Lobbying Disclosure Act reports with the Senate during 2019. This report focuses on lobbying activity of 302 top lobbying firms – those that reported \$1 million or more in revenue in 2019.

Every year, BGOV identifies top-performing firms, measured by five critical business performance metrics. Bloomberg Government's standout firms exhibited growth in revenue and average revenue per client; high short- and long-term customer retention rates; and exceptional revenue per registered lobbyist.

Detailed analysis of fourth-quarter and full-year activity for every registered lobbying firm and lobbying client is currently available on Bloomberg Government.





Standout Lobbying Firms of 2019

Bloomberg Government identified 43 major lobbying firms that exceeded thresholds in several key business metrics in 2019. Criteria focus on growth, customer satisfaction, and profitability.

These firms met the following specific criteria:

Revenue growth

• Positive percentage change in revenue, compared with 2018

Growth in average revenue per client

• Positive percentage change in average revenue per client, compared with 2018

Client retention as of the fourth quarter of 2019

- One-year client retention rate of 80% or more
- Three-year retention rate of 55% or more

Employee profitability

 Revenue per registered lobbyist (number of lobbyists as of the fourth quarter of 2019) of \$450,000 or more






